For the last few years the Rhododendron, Camellia & Magnolia Group has been actively supporting the conservation of threatened species and hybrids. Over a longer period we have established four successful collections of rhododendrons and one of magnolias, all open to the public for education and enjoyment.

Starting with our initiative to help Bodnant safeguard some of its important hybrids through the funding of a programme of micropropagation, we have now been involved in the rescue and re-establishment of a large number of rhododendrons which otherwise could have disappeared.
